

**1) Conference on “The Impact of Emergency Rules on Religious Freedom, with Special Regard to Religious Minorities”, Department of Law & Ph.D in Legal Studies, University of Messina, July 24-25, 2024**

Abstract: The conference will analyze the status of the religious minorities in different geographical and legal contexts and the impact of the emergency generated by the Covid-19 pandemic and the war on the legal treatment of the minority groups. Emergencies have a negative impact on the collective dimension of the freedom of religion, exacerbating the already fragile balance between majorities and religious minorities. The practices and the rituals of minorities have less chance of being safeguarded for several reasons: a) they could not/were able to avail of alternative way of worship; b) some media – such as television – have not been made available equally to all religious groups; c) some religious communities enjoy from the outset a legal status of minor protection (e.g., in Italy religions without agreement with the State). In some non-European contexts, where the minorities are already victims of discrimination linked to specific social, historical, economic and political contexts, and the religious factor is the subject of increasing politicization, the pandemic emergency has further exacerbated intra-confessional divisions and the contagion containment standards have also been used to justify forms of repression, persecution and discrimination against traditionally marginalized groups, some of whom are also accused of contributing to the spread of Covid-19 as well of war fighters support. With an inter-sectional approach, the unit of Messina will analyze the different ways of managing the religious pluralism and the complex relationships between minorities and traditional religions in various legal systems, investigating the role played by the religious factor in the process of integration of different cultural and religious identities. The complexity and the multidimensional character of the religious phenomenon, and its intimate connection with social, economic and political factors, will be studied in an interdisciplinary approach and a multi-level analysis. The conference will investigate if and how the impact on the initial legal framework of the extraordinary measures aimed to contain the spread of Covid-19, have accentuated inequalities and conflicts, probably emphasizing dangerous anti-democratic and anti-pluralistic tendencies. The goal is to provide an overview of the different models of management of religious diversity, to identify policies that can encourage the implementation of the principles of equality and non- discrimination. The speakers will focus on both legislative and jurisprudential choices and on documents that allow to identify the strategies pursued in different legal contexts in terms of social cohesion and constructive dialogue among different systems of values. Concrete operational regulatory and administrative solutions will be proposed with a view to the adoption of inclusive anti-discrimination public policies, which can balance the specific needs of minority groups with public health protection needs, security and stability.

**2) Conference on “Religious Freedom of Minority Groups in Times of Ongoing Crisis.”  
May 22-23, 2025, Department of Law Ph.D in Legal Studies, University of Messina.**

Abstract: Part of a PRIN project, the event aims to examine the interaction between emergency law and religious freedom, focusing specifically on the impact of the emergency generated by the Covid-19 pandemic and the Russian-Ukrainian conflict on the legal treatment of minority groups. Emergencies negatively impact the collective dimension of religious freedom, exacerbating the already fragile balance between religious majorities and minorities. The purpose of the conference is to examine whether, and to what extent, emergency regulations have a discriminatory effect on religious minority groups. Indeed, these groups often complain that seemingly neutral regulations enacted during emergencies have a disproportionate impact on their practices and rituals and have been conduits of contagion. Furthermore, in some geographical contexts, where minorities are already victims of discrimination linked to specific social, historical, economic, and political contexts, and where religion is increasingly politicized, the conference aims to explore how the pandemic emergency has further exacerbated intra-confessional divisions. The key question is whether contagion containment measures have also been used to justify forms of repression, persecution, and discrimination against traditionally marginalized groups, some of whom are also accused of contributing to the spread of Covid-19. In turn, the Russian-Ukrainian conflict has generated new challenges for various religious communities, resulting in human rights violations. Although violations of religious freedom have been observed in Ukraine since 2014 (in Crimea

and other occupied territories), Russian aggression against Ukraine since 2022 has exacerbated this phenomenon, in terms of the destruction or expropriation of places of worship, persecution of religious minorities, and crimes against ministers of worship, culminating in controversial regulatory responses. Bringing together leading scholars from diverse geographical areas, the conference aims to analyze the different approaches to managing religious pluralism and the complex relationships between minorities and traditional religions in different legal systems, exploring the role played by religion in the process of integrating diverse cultures, cultural, and religious identities. The complexity and multidimensional nature of the religious phenomenon, and its intimate connection with social, economic, and political factors, will be analyzed from an interdisciplinary perspective. The various presentations will explore whether and how the impact of emergency measures on the initial legal framework has accentuated inequalities and conflicts, likely emphasizing dangerous anti-democratic and anti-pluralistic tendencies. The conference aims to provide an overview of the different models for managing religious diversity, in order to identify policies that can encourage the implementation of the principles of equality and non-discrimination. The investigation will extend to the various legislative and case law choices with a view to comparing the strategies pursued in different legal contexts in terms of social cohesion and constructive dialogue between different value systems. It will also identify concrete operational solutions, both regulatory and administrative, for the adoption of inclusive and anti-discriminatory public policies capable of balancing the specific needs of minority groups with the requirements of public health, security, and stability.

**4) EUARE 2025, July 9, 2025, Panel on “Conflicts, Emergency Rules and Religious Minorities”.**

Abstract: Modern democracies are undergoing unparalleled times. The war in Ukraine, October 7th 2023 and the conflict in Gaza, acted as a stress test for democratic societies, giving rise to political and economic uncertainty, and to decline of public trust. Emergency challenges significantly affected the exercise of fundamental rights, whose protection is grounded in constitutional, supranational and international provisions. The panel aims to examine the interaction between emergency law and religious freedom during conflicts in the European landscape (and beyond). The focus will be on the impact of the emergency rules and policies on religious freedom and their implications for minority groups. As research has shown, emergencies negatively impact the collective dimension of religious freedom, exacerbating the complex dynamics between religious majorities and minorities.

Furthermore, this panel aims to investigate the impact of emergency rules as linked to conflicts on rights of religious minorities and rising discriminations and prejudices against religious groups in times of crisis. Finally, it aims to address future scenarios in Europe (and beyond) for managing religious diversity and implementing the principles of equality and non-discrimination, with a view to enhancing inclusive and anti-discriminatory public policies, and reconciling the protection and promotion of minority groups with the public interest to guarantee public health, security and sustainability.
